

## General Terms and Conditions of trans-o-flex Express GmbH & Co. KGaA (Status 09/2021)

## **Appendix Weights and Dimensions**

1.1. The maximum weight of packages must not exceed 32 kg, the maximum length of packages must not exceed 150 cm and the girth must not exceed 300 cm while the minimum dimensions must not be less than 20 x 15 x 2 cm and the minimum weight must not be less than 200 g. Packages within the stated limits are sortable. Full pallets handed over may not exceed 500 kg in weight, 120 cm in length, 80 cm in width and 200 cm in height (incl the height of the loading device).

1.2. In the "trans-o-flex ambient" range the weight of packages in the "Package" classification must not exceed 25 kg, and the dimensions must not exceed 60 cm in length, 40 cm in height and a girth of 220 cm. The maximum weight of a full pallet must not exceed 500 kg, and the dimensions must not exceed 120 cm in length, 80 cm in width and 180 cm in height (including the height of the loading device).

- 1.3. Goods which cannot be put onto a sorter (casks, canisters, rolls, sacks or posters etc.) will be subject to an NC (non conveyable) surcharge.
- 1.4. Individual packages must not be bundled or tied together to form a single package. trans-o-flex shall reserve the right to refuse to transport such packages, or to separate them into individual packages again, and to charge a handling fee for each package.
- 1.5. Packages and full pallets having one or more dimensions exceeding the set figures may be rejected and returned to the sender at the sender's expense, or delivered outside the standard delivery times, while surcharges reflecting the additional expenditure incurred may be charged.
- 1.6. Consignments consisting of 30 or more packages are to to be handed over on a pallet.
- 1.7. The weight of packing and loading devices shall be included in the weight chargable as freight. If no weights are stated packages will automatically be charged with 15 kg and full pallets will be charged with 200 kg, unless we have been able to prove that the package or full pallet was heavier.
- 1.8. Bulky goods shall be charged on the basis of dimensional weight. Goods whose dimensional weight is greater than their actual weight are regarded as being bulky goods. The dimensional weight is calculated on the basis of 1 cbm = 200 kg.
